'Operation Globe'

Dorset Police & The Bournemouth Partnership

Description of project - explanatory notes:

During late 2002, the Bournemouth Division was clearly failing to achieve targets in relation to town centre vehicle crime. Incidences of violent crime and disorder were also rising, as were complaints from members of the public in relation to nuisance behaviour. A strategic assessment for the town centre was prepared, an abridged version of which forms part of this submission.

It was further identified that key agencies were not working together as well as they might, so a multi agency group with clear responsibility to work towards achieving government and CDRP targets was proposed.

This meeting sits once a month as a tasking and co-ordinating group, acting upon recommendations raised through problem analysis and tactical assessment. Each member is responsible for progressing actions allocated to their agency; an 'action & results' sheet is kept, circulated to all members of the group. A copy of this is attached to this submission.

'Operation Globe' has received widespread coverage in the local press and is becoming well known to residents, workers and local visitors. Challenges still remain, notably in relation to violent crime and robbery offences, but, overall, communication and partnership working has been demonstrably improved, to the ultimate benefit of Bournemouth town centre users.

"OPERATION GLOBE" - DORSET POLICE & PARTNER AGENCIES

The Problem

The town centre of Bournemouth is regarded as a valuable, 'postcard' tourist attraction, offering numerous quality shops and entertainment venues, together with close proximity to the beach and pleasure gardens. A growing problem of nuisance behaviour and drug abuse, with disorder and violent crime during the evening, was identified through performance indicators, negative letters from the public and adverse press coverage. A strategic assessment using police information confirmed the problem.

The Response

Although not specifically set up as a Problem Oriented Policing project, 'Operation Globe' follows the National Intelligence model, from strategic assessment, through tactical assessment and recommendation, to tasking and evaluation. It recognizes that the town centre is of major importance to the economy of Bournemouth Borough as a whole. Each tasking group member seeks:

- To make the centre of Bournemouth an even more safe and pleasant place in which to live, work or visit, for all sections of the community
- To work together in partnership as key agencies responsible for public safety and wellbeing in the town centre, with clear acceptance of responsibility and empowerment to act on behalf of the organisation represented
- To reduce crime, disorder and nuisance within the town centre
- To give reassurance to members of the public in the form of regular updates on the work and success of the group
- To have due regard for statutory responsibilities under section 17 of the Crime and Disorder Act 1998

Represented on the 'Globe' Tasking & Co-ordinating Group (TCG) are Bournemouth Borough Council (Cabinet Leader, Town Centre councillor, Technical Services, Parks & Countryside Dept., Community Safety, Licensing Enforcement); Town Centre Management; Bournemouth Retailers Reducing Crime; Drug Action Team; entertainment venues and Trading Standards.


Police representation includes the section commander, Information Analyst, Crime Reduction, Licensing and patrol officers.

Impact

Initial figures for the first 3 months indicate:

- thefts from vehicles down by nearly 60% (67 fewer offences) and thefts of motor vehicles down by a similar amount (20 fewer offences)
- drug possession arrests up 23% (22 offences)
- criminal damage offences down 24% (38 offences)
- complaints of nuisance or anti social behaviour have dropped 33% (166 occurrences)
- Editorial in the 'Bournemouth Evening Echo' ".....this area is buzzing at the moment and there are many positives including our policing strategy to celebrate".






BOURNEMOUTH TOWN CENTRE (BOCD) STRATEGIC ASSESSMENT DECEMBER 2002

- 1. Bournemouth an overview
- The Bournemouth Central Section of this Division covers an area of just over 16 square kilometres, with a population of about 27,500 (16.9% of the boroughs population) and 12,500 households.
- Beat area BOCD has a population of approximately 3,300 and contains about 1,600 households.
- On the 22nd of August this year, between 7 in the morning and 7 in the evening, 6.5,442 persons passed through Bournemouth Square! This number is expected to at least double in the fortnight leading up to Christmas.
- Bournemouth Borough Council publicise details of 2,894 business premises in the borough on their web site¹
- Within the Section there is only one publicly funded school, St Michael's Primary in Somerville Rd.
- Bournemouth University is housed within the Section. For the academic year 2001/02 The University attracted just over 15,000 students in total of which 1,300 were from overseas. In addition The Bournemouth A Poole College has a main education centre at the Lansdowne with a sister site in Poole. Between them the two sites attract some 27,000 students annually, of which about 1,500 are from overseas.
- In the past year some 351 students residing in Bournemouth have been arrested or dealt with for criminal matters.
- The Town Centre has a very busy night life with *an* abundance of licensed premises having closing times spread between 2300 and 0300hrs. These premises have the potential to hold in *excess* of 12,700 customers at 2 o'clock in the morning.

2. Reaching Targets

The Dorset Police Authority Annual Policing Plan² and the Bournemouth Division Policing Plan for 2002-2003 both broadly *reflect* the same targets for crime and incidents as each other which can be somewhat abridged *as* follows:-

- · Reduce incidents of violent crime
- Increase the detection rate for violent crimes
- Increase the number of offenders dealt with for Class A drug supply offences
- Reduce dwelling burglary to 10.2 offences per 1000 households
- Reduce repeat victims of dwelling burglary to 6.97o
- Increase primary burglary detection rate to 18.2%
- Reduce vehicle crime to 12.8 offences per 1000 population
- Increase vehicle crime detection rate to 10.8%
- · Reduce the number of road traffic casualties
- Improve response times to calls from the public.

The Bournemouth Partnership Community Plan, of which we *are* an integral and active member, has set ten targets for the partnership to achieve although not all relate

directly to Policing issues³. Those that obviously do reflect on the Policing of the Borough *can* be *seen* to again broadly fall in line with the Police Authority Plan and the Divisional Plan :- ...

- Reduce: house burglary to 9.6 per 1000 households in 2004/5; vehicle crime to
 12.8 per 1000 population in 2002/03; and non-domestic violent crime in public places to 2.5 per 1000 population in 2002/3.
- Reduce accidental fire in the home by 20% below the 5 year projected trend.
- Reduce the current 5-year average of heathland fires by 25% between April 2000 and April 2005.
- Increase the number of offenders *referred* within the existing Arrest-Referral scheme by 5% each year.
- Keep the level of rough sleeping in Bournemouth to as near zero as possible each year.
- Reduce the number of unfit houses in Bournemouth by 5% per year
- Provide a minimum of 36 Drug Treatment and Testing Orders every year.
- Develop consultative networks, where all minority issues *can* be addressed and produce effective responses to *concerns* raised, by April 2003.
- Review and test all local emergency, contingency and disaster recovery plans on an annual basis.
- Bring together a network of Bournemouth consumer and legal advice agencies by 2005 to: a) research present services b) identify unfulfilled need for services c) ensure appropriate and adequate services are in place d) ensure high public awareness of such services.'

According to a Government Web site 'Anti-social behaviour includes harassment, intimidation, vandalism, dumping cars, drunk and disorderly behaviour and littering.'4

Crime Trends


3. Dwelling Burglary.

Across the Central Section dwelling burglary can be *seen* to have reduced in volume from 383 in 1997 to 192 (to date) in 2002 (Calendar years) representing a reduction of 23.5%. This means that in relation to the Governments Crime Reduction Strategy we are close to realising the target some 18 months in advance of the 'due date'.

A look across the beat *areas* in the section reveals that all beats record a significant reduction <u>other than BOCD</u>. which in fact shows an *Increase* in reported dwelling burglaries of nearly 70% over 5 years.



The chart above examines dwelling burglary by beats within the Central Section over the past 5 years, quoting the average number of dwelling burglaries per beat in each year with an additional final column for the 5 year monthly average (which does not include 2002 figures). Figures for 2002 only apply to the first 10 months but checks to date indicate that they are unlikely to be much altered by the end of the year.

As a 1007o stacked chart this indicates how dwelling burglaries in each beat area have contributed to the total in the Division on a yearly basis, and how the significance of each beat has changed over time. It identifies that over time: -

- beat BOCD has increased in significance now accounting for 29.87o of total dwelling burglary crime
- beat BOCE now only accounts for 5.5% compared with 27.6% 5 years ago
- beat areas BOCB and BOCD account for over 56% of the Sections total dwelling burglary crime.
- Dwelling burglaries in Beat area BOCC have fallen significantly since 1997 but little change has occurred in the last 3 years



This data therefore provides good evidence in respect of the shifting problem areas and the mean monthly values would appear to be good indicators. *On* the basis of this data alone BOCB and BOCD are the two beat *areas* in which to concentrate resources. How/ever the following charts enhance the context of burglary data by looking at dwelling burglaries together with population figures, number of households and, *Therefore*, the number of burglaries per beat per 1000 households. From these charts it *can* be seen that only in beat *areas BOCA & BOCE* is the current Policing Plan target of reducing dwelling burglaries to 10.2 per 1000 households being satisfied. It also highlights that beat *area BOCC* is in fact by far the worst affected by dwelling burglary so far this year.

Current Policing Plan targets include the reduction of dwelling burglary "per thousand households to 10.2". *Across* the Central section between January and November this year the figure reached has been 13.75.

4 Vehicle Crime

Over the last 5 years vehicle crime has accounted for just over 22% of all crime committed in the Division.


- For the first quarter of this year acquisitive vehicle crime (all types) accounted for some 22.3% of reported crime in this Division.
- In 2001 thefts from vehicles accounted for 26.6% of the Divisions total reported crime, 1% less than in 2000.
- 38.7% of all thefts from vehicles reported to Dorset Police in 2001 occurred in the Bournemouth Division.
- British Crime Survey figures estimate that offences of thefts from vehicles may be as much as 100% under-reported.

In the Central Section thefts from vehicle's account for between 15 & 18% of all crime, approximately 40% of that occurring in beat area BOCD. A fairly accurate rule of thumb is that thefts from vehicles account for about 75% of all vehicle crime and this figure tends to remain true over time.

This Division has been set a target to reduce vehicle crime by 5% in 2002/2003 in order to reach *an* overall target of reducing vehicle crime by 30% by the 31st of March 2004 from the level in 1998/1999.

- At the end of the financial year 1998/99 there had been a total of 4688 reports of vehicle crime
- A 30% reduction on this figure equates to a total of 3282 reports by 2003/2004
- At the end of the financial year 2001/2002 there had been a total of 4137 reports of vehicle crime.
- That equates to a reduction over 3 years of 11.75%
- We have 18 months in which to reduce vehicle crime by a further 28.25% across the Division
- However
 - > After the first 6 months of this financial year vehicle crime reports stand at 2119
 - > Over the same period in 2001/02 there had been 1832 reports
 - > More thefts from motor vehicles have occurred in the last 9 months in this division than in the first 9 months of any year since 1999 (but we are only down on 1999 figures by 4.5%)
 - > There is no reason to believe that vehicle crime figures have been noticeably affected by ethical recording practices taken on in April of this year.

With respect to the Central Section the below chart clarifies the problem areas for us and also indicates that for this section there is a long way to go to meet the targets of the Crime Reduction strategy.



Since 1997 thefts from motor vehicles have reduced significantly in beat area BOCC only. Whilst they have reduced in BOCE it must be taken into account that the beat boundary itself has altered significantly in the last 2 years. Overall we have recorded more thefts from motor vehicles this year (to date) than in any year since 1996. * To reach the targets set by the Dorset Police Authority Plan, The Divisional Plan and the Bournemouth Partnership Plan vehicle crime now needs to be reduced by somewhere in the region of 70%

58% of vehicle crime occurring in BOCD this year has taken place in a public car park, of that (331 crimes) 62% has occurred in Council owned *car* parks and the remainder in the 3 privately owned public *car* parks in the town.


BCU's and CDRP's across the U.K. *are* grouped together in what is termed 'family groupings' of similar towns/areas. Bournemouth BCU & CDRP *are* in family group 8, together with Poole and Christchurch/Eastern Division. The national crime statistics for 2001/02 show that, per thousand of population, Gloucester is the only member of our family grouping with more thefts from motor vehicles than Bournemouth.⁵

Vehicle crime performance is measured by offences per thousand of population with our target being 12.8 for the Division. The 2001/02 figure was 18.1, currently (and this is only 8 months into the year) it is 17.7. In Bournemouth section it is somewhere in the region of 44 whilst in beat *area* BOCD it is currently about 155!

Figures for vehicle crime *can* be quoted in many different ways but the end result is quite simply that this type of crime is rising, and has been doing so for some time. *As a* Division, section and CDRP we are failing to reach the targets set, or indeed making any headway towards them.

5. Violence

 $35.87_{\rm O}$ of violence in the County of Dorset is committed in the Bournemouth Division (2002 reported crime figures) of which 14.2% is committed within the Central Section. Over 60%. of this violent crime is linked to alcohol

Per thousand of population the number of offences of violence in Dorset as a whole is 18.9 whilst in Central Section it is 38.3. However the population of Bournemouth town *soars* by the thousand every night of the week so this is perhaps not a good indicator of the level of violence experienced.

In April 2002 the Home Office counting rules for recording of crime changed significantly and this has had a profound effect on the level of <u>recorded</u> crimes of violence. Many incidents are now recorded as crimes that would not have been so recorded under the "old" counting rules. It is therefore very difficult to assess the level of violence in the County, Division or section at this time, as there are no truly comparable figures to research against.

2001/02 published crime figures recorded a 22.8% rise in violence over the previous year for the Bournemouth Division⁶, however even these figures *are* difficult to *assess as forces* and Divisions approached the recording of violence in different ways. Poole Division recorded a rise in violence of 61.9%!




For the Central section the main backdrop against which we see and experience violence is night life in the town and the abundance of licensed premises. As stated earlier there is a potential influx into the town centre at night time of nearly 4 times the resident population. Having said that there is also a significant amount of violence during the daytime as well, a factor that should not be ignored just because we associate violence with night time and alcohol. In fact daytime violence has increased to a greater degree than night time violence.

The following charts and data *were* prepared earlier this year for the Licensing department and deal with violence, drunkenness and disorder/anti social behaviour. They make it quite clear where and when such offences and incidents are occurring within the section.

When and where does crime and disorder occur in *BOCD?* Not surprisingly it is found that only a few roads attract the majority of violent incidents, namely Fir Vale Road, Pier Approach, Old Christchurch Rd and Hinton Road with the majority taking place between midnight and 2am.


Roads with over 9 Crimes (all types) recorded July, Aug, Sept 2002






WHEN AND WHERE DO INCIDENTS OCCUR?

- 7. Other Crime types
- 7.1 Bournemouth Town boasts 1 less shop than Boscombe but 46,897 square metres more shop floor space! (figures from 2000)
- 7.2 In 2000 the town had 342 retail outlets.
- offences of theft by shoplifting, an increase of 102 offences over the same period (11 months) in 2001. The retail sector is also the main target for the unlawful use of cheques and credit cards. In the first 11 months of this year Dorset Police have recorded over 1,500 accounts that have been fraudulently used in retail premises in the Bournemouth Division. Data from arrest referrals and Drug treatment centres etc firmly establishes theft by shoplifting as the domain of the addicted dass A drug user. As a type of crime committed to fund class A drug addiction it is the most favoured source of unlawful income. Research into the disposal of stolen property has similarly shown that the dass A drug user is most frequently the first port of call for a thief wishing to dispose of stolen cheques and bank/credit cards⁷.
