Scanning:

The Safer Lewisham Partnership have been operating a Joint Action Group (JAG) which takes the tactical approach to dealing with reducing crime. The group is represented by members from the partnership to ensure that a comprehensive approach is taken.

The Partnership was concerned about the high levels of robbery, residential burglary and motor vehicle crime. In 06/ 07 the numbers were rising significantly.

The JAG were able to hotspot map the offences with partners contributing in relation to key events taking place/ interventions that targeted offenders were on, and other environmental data that gave a full picture of the problems. <u>Analysis:</u>

Using the NIM model robbery, motor vehicle crime and residential burglary were analysed through the partnership to help identify what resources need to be deployed and how short, medium and long term outcomes could be achieved.

Response:

The response was centred around the DIPFIT model.

Assessment:

Robbery has reduced by 40%, which equates to approximately 1000 less victims; the highest victim reduction within London.

Motor vehicle crime, was predicting a rise about 20% has now shown a reduction of 0.3% year to date.

Residential burglary has shown a reduction of 11.3% year to date from a 20% increase in June 2007.

Overall crime has also reduced by over 8% and detected crime has been increased from 16% in June to over 24%.

The progress has been through a joint tasking and joint resourcing in relation to tackling the problem. Using the NIM model and applying a range of activities from targeting, enforcement, intervention, prevention, and education the problem has a multi dimensional solution focused outcome.

This work has a sustainable element as it means that prevention and education remains in place with the ability to continue to assess and analyse a problem and move the approach to new locations as required.

Scanning:

The Safer Lewisham Partnership has been operating a Joint Action Group (JAG) which takes the tactical approach to dealing with reducing crime. The group is represented by members from the partnership to ensure that a comprehensive approach is taken.

The JAG is not simply an additional partnership or performance meeting but fits in with both the police and council performance structure providing the tactical performance delivery link between partners. There was concern that there was no joint tactical delivery structure within the Safer Lewisham Partnership which meant that the strategic intentions of the partners were not being efficiently delivered. A consultation and discussion event was organised with the strategic leads and a theoretical model developed. This was then refined to produce the practical working model of JAG. Since implementation non-statutory partners have taken up roles on the JAG to provide representation from the business and residential communities.

Initially robbery was the only crime type that the JAG looked at. This allowed us to develop the process and ensure its efficacy before introducing other crime types. Problem profiles were compiled for each crime type and shared throughout the partnership before an initial meeting to develop plans for reduction. JAG meeting were scheduled to follow the police tactical tasking meetings and focus on specific areas through out the year according to planned operations. There is flexibility within this to allow for activity to deal with developing trends.

The Partnership was concerned about the high levels of robbery, residential burglary and motor vehicle crime. In 06/ 07 the numbers were rising significantly. The JAG were able to hotspot map the offences with partners contributing in relation to key events taking place/ interventions that targeted offenders were on, and other environmental data that gave a full picture of the problems. In order to support the new mechanisms the partners information sharing and communications strategies have been reviewed and updated.

Analysis:

Robbery: Lewisham had seen a significant increase in robbery over the past 3 years, but with close analysis and the partnership championing the need for reduction a comprehensive approach was adopted. There were some easy wins around 'getting the basics right' in relation to enforcement and intelligence. It was identified that 80% of all first time entrants into the system were committing robbery, and of those about 90% were black males. Most perpetrators of robbery were also victims of robbery.

Motor vehicles: 17% of all theft from **motor vehicles** included number plates. It showed that this was taking place in a specific area mostly and that the key environmental issues were around overgrown bushes. **Residential burglary:** time and place hotspotting identified a range of issues including an increase in artifice burglary, letterbox burglaries, and mortice lock breaking burglaries. It was identified that many burglaries were taking place in blocks of flats, where people were let into the block by others not knowing who they were there to see. **Response:**

The response was centred around the DIPFIT model.

Robbery:

Increased targeted policing was in place, with Q cars being tasked to tackle the known robbers. CPS and court systems were tightened up, and if an action was to be undertaken it was done as agreed. Restorative justice approaches were used in secondary schools, working to help reduce becoming a victim of robbery as well as placing responsibility on the perpetrators of their actions.

Theft from motor vehicles:

Additional SNT patrols were put in the area, with community wardens also being tasked to increase visibility at peak times and locations. Leafleting in specific areas to highlight the issue to residents. Prevention and education work was undertaken through the use of the Safer Lewisham bus, which was situated in specific locations in providing residents with 'security bolts; for their number plates to help reduce this theft. Overgrown bushes were cut back through environmental services and the payback scheme. Information was placed in shops selling sat navs to remind people not to leave them in cars. Retailers were very positive about the initiative.

Residential Burglary:

Increased patrols of SNT and community wardens were located in appropriate places. The use of the adult social care team enabled prevention messages to be taken into homes of the vulnerable in relation to artifice burglaries in

the identified hotspots. Wardens were trained in crime prevention so that on their patrols they could advise residents if they saw things that could make a home more prone to burglaries. A list of known burglars was produced and each was monitored in relation to interventions in place, or ensuring that upon release they were supported through a carrot and stick approach back into the community.

Officers were briefed on the 'fake keys' that were being used to open mortice locks so that if people were stopped and searched these could be identified.

SNT and community wardens were spot checking communal blocks and ensuring that the doors were secured and people were aware of not letting strangers into the blocks.

Prevention messages and targeted advice was provided by the partnership.

Assessment:

Robbery has reduced by 40% which equates to approximately 1000 less victims; the highest victim reduction within London.

Motor vehicle crime, was predicting a rise about 20% has now shown a reduction of 0.3% year to date.

Residential burglary has shown a reduction of 11.3% year to date from a 20% increase in June 2007.

Overall crime has also reduced by over 8% and solved crime has been increased from 16% in June to over 24%.

The progress has been through a joint tasking and joint resourcing in relation to tackling the problem. Using the NIM model and applying a range of activities from targeting, enforcement, intervention, prevention, and education the problem has a multi dimensional solution focused outcome.

This work has a sustainable element as it means that prevention and education remains in place with the ability to continue to assess and analyse a problem and move the approach to new locations as required.

New links and relationships have been developed from these meetings and unexpected opportunities for problem solving have been identified all leading to more efficient partnership working.

An additional level of management has been introduced in the form of the Performance Delivery Group. This meets monthly with representation at Director level in the council and Superintendents from the police and allows the Safer Lewisham Partnership to meet only quarterly and concentrate on strategic issues rather than tactics or delivery.
